How and why we use your personal Data?

- To fulfil our administrative purposes and protect our companies & interests.

Visitors to our Website & Social Media Feeds

When someone visits our website we use a third-party service, e.g. Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make any attempt to find out the identities of those visiting our website.

If we do want to collect personally identifiable information through our website, we will be up front about this. We will make it clear when we collect this information and will explain what we intend to do with it. Social media websites/apps such as Facebook, twitter & LinkedIn have their own privacy policies and run their own analytics to collect your personal profile data dependant on your profile settings.

Photos; Photos will be taken/stored by the Data Controller on password protected devices and stored for as long as deemed necessary in the interest of the company's future promotional purposes.
